Did You know?

To establish a new group, a form called the "G.S.O. New Group Listing Form" (F-30) needs to be filled out and sent to NY. The form can be found as follows:

- AA.org
 - Click on the magnifying glass in upper right hand corner
 - Type in the bar "New Group Form"
 - Click on the top item on the list that appears
 - Click on View PDF
 - Click on Print
 - Instructions are included with the form.
- Be sure to notify District 7 and Central Office as well
 - Once group is formed, District 7 and Central Office need to be notified about any changes to your group (group name; meeting place, time, date of location; group contact) using the "Meeting Information Form" which Central Office can send via email.
